Applied Physics Letters is published semimonthly by the American Institute of Physics with the cooperation of the American Physical Society and the Optical Society of America. Its purpose is to provide rapid dissemination of new developments in fields regularly covered by the *Journal of Applied Physics*.

Information for Contributors

Submit manuscripts to Gilbert J. Perlow, Editor, *Applied Physics Letters*, Argonne National Laboratory, P.O. Box 296, Argonne, Ill. 60439. Submission is a representation that the manuscript has not been published previously nor currently submitted for publication elsewhere. The manuscript should be accompanied by a statement transferring copyright from the authors (or their employers—whoever holds the copyright) to AIP; a form for copyright transfer is occasionally printed in the back of this journal and is available from the Editor's office or AIP. This written transfer of copyright, which previously was assumed to be implicit in the act of submitting a manuscript, is necessary under the new (1978) U.S. copyright law in order for AIP to continue disseminating physics research results as widely as possible. Further information may be obtained from AIP.

Publication Charge: To support the cost of wide dissemination of research results through publication of journal pages and production of a data base of articles, the author's institution is requested to pay a *page charge* of \$95 per page (with a one-page minimum) and an *article charge* of \$20 per article. The page charge (if honored) entitles the author to 100 free reprints. For Errata the minimum page charge is \$10, with no article charge and no free reprints. Non-payment of the publication charge may lead to delays in publication.

Timeliness and current importance of the subject matter, and brevity and clarity of the presentation determine the acceptability of contributions. Feasibility studies and mere proposals for future research seldom meet the criteria for acceptability. Contributions lacking the element of urgency may be acceptable as Communications in the *Journal of Applied Physics*. Each Letter should be reasonably self-contained, and may on occasion be followed by a comprehensive report in the *Journal of Applied Physics* or elsewhere. Results of an extended research program should not be presented as a series of Letters in place of a comprehensive article.

Manuscripts should normally be planned to occupy two journal pages or less, and must include an abstract limited to about 100 words. In addition to the title, abstract and references, two pages permit about 1800 words of text, reduced however by allowances for equations, tables, and figures. An average one-column figure with its caption will displace about 220 words of

text. In some cases a longer manuscript may be justified, but a Letter may never exceed three journal pages. Authors are cautioned that discovery of excess length might not occur until a late stage in publication and would then result in delay and expense. Circumvention of the length limitation by division of a long article into smaller parts is considered to be contrary to the purposes of this journal.

Instructions for preparation of manuscripts will be found in the 1 January and 1 July issues of this journal and occasionally in later issues. In brief and incomplete summary: Two copies of the manuscript, including clear copies of the figures, are required, double spaced throughout on one side of 21.6 X 28 cm (8½ X 11 in.) paper. The original should be retained by the author until it is requested, after review. The *abstract*, *references*, *figure captions*, and *tables* are similarly to be double spaced each on its separate sheets. The original *figures* should be original line drawings or high-contrast glossy prints not larger than 21.6 X 28 cm and should be included with the original submission. *References* should conform to the style used in AIP journals including this one. Unusual mathematical symbols should be clarified with marginal notes.

AIP's **Physics Auxiliary Publication Service (PAPS)** is a low-cost depository for material which is part of and supplementary to a published paper, but is too long to be included in the journal; inquire of the Editor.

Proof and all correspondence concerning papers in the process of publication should be addressed to: Editorial Supervisor, *Applied Physics Letters*, American Institute of Physics, 335 East 45th Street, New York, N.Y. 10017. In all correspondence reference should be made to title, author, journal, and scheduled date of issue. A limited number of **alterations in proof** are unavoidable, but the cost of making extensive alterations after the article has been set in type will be charged to the author.
