THE JOURNAL OF MATHEMATICAL PHYSICS is published monthly by the American Institute of Physics. Its purpose is to form a medium of publication of highly mathematical physics articles and papers on branches of mathematics that are currently or potentially useful for the development of theoretical physics. Mathematical manuscripts should be written in a manner that is understandable to theoretical physicists. Although most papers appearing in this journal are original, occasionally reviews of mathematical topics of interest to physicists will be published.

### Information for Contributors

Send manuscripts to Elliott W. Montroll, Editor, *Journal of Mathematical Physics*, Physics Department, University of Rochester, Rochester, N.Y. 14627. Unless stated otherwise, submission of a manuscript will be understood to mean that the paper neither has been copyrighted, classified, published, nor is being considered for publication elsewhere.

Manuscripts should be typewritten in black ink on durable white paper, and on one side only. They should be double-spaced (including abstracts and references) with wide margins, and an original submitted to the Editor. Authors should retain a copy of their manuscript and whenever possible submit a copy with the original. The *Style Manual* of the American Institute of Physics will be most helpful in the preparation of manuscripts. The authors' institutions are requested to pay a publication charge of \$60.00 per page—which, if honored, entitles them to 100 free reprints—plus a \$10.00-per-article charge toward the support of its abstracting and indexing in *Physics Abstracts*. Instructions will be sent with galley proofs.

Proper references to earlier publications should be given. The abstract of the paper must emphasize the new results. It should be short and complete within itself so that it may be utilized in the abstract journals.

All mathematical expressions, insofar as possible, should be typed, with unavailable symbols inserted neatly in ink. Be sure to distinguish between capital and small letters. Avoid complicated superscripts and subscripts. Avoid repetition of a complicated expression by representing it by a symbol. Identify in the margin Greek letters and unusual symbols the first time each occurs. Use fractional exponents instead of root signs. Use the solidus (/) for fractions wherever its use will save vertical space.

References should appear as consecutively numbered footnotes, and should be listed together on separate page(s). Literature citations of technical journals should be in the form indicated in the *AIP Style Manual*. There should be no reference to classified publications even if their titles are unclassified.

Tables should be typewritten on sheets separate from the running text. Each table must have a caption that will make the data in the table intelligible without reference to the text. Avoid complicated column headings.

Wherever possible, figures should be planned for the width of a column (3 in.). A convenient reduction ratio is about 2:1 or 3:1. Lettering should be large enough on the original so that when reduced it shall not be less than about  $\frac{1}{16}$  in. (~1.5

mm). Line drawings must be in india ink on white paper or tracing cloth. Coordinate paper is not desirable, but if used must be blue-lined and the coordinate lines meant to be shown must be inked over. Pictures of apparatus, etc., should be glossy prints and have maximum black and white contrast. Identify each original drawing or photograph on the back in the lower right-hand corner with the author's name and the figure number. Figures should be numbered consecutively. Captions should be typed on a separate sheet of paper.

A limited number of alterations in proof are unavoidable, but the cost of making extensive alterations after the article has been set in type will be charged to the author.

Proof and all correspondence concerning papers in the process of publication should be addressed to the Supervisor, Editorial Department, American Institute of Physics, 335 East 45 Street, New York, New York 10017. Reference in all correspondence must be made to title, author, journal, and scheduled issue.
