Eby, National Bureau of Standards, Washington, DC 20234, respectively. **Publication Charge:** To support the cost of wide dissemination of research results through publication of journal pages and production of a data base of articles, the author's institution is requested to pay a *page charge* of \$75 per page (with a one page minimum) and an *article charge* of \$20 per article. The page charge (if honored) entitles the author to 100 free reprints. For Errata the minimum page charge is \$10, with no article charge and no free reprints. Nonpayment of the publication charge may lead to delays in publication. Instructions will be sent with galley proofs. Authors are advised to consult the "Suggestions for Contributors" in the January Issue.

Proof and all correspondence concerning papers in the process of publication should be addressed to Editorial Supervisor, *Review of Scientific Instruments*, American Institute of Physics, 335 East 45 Street, New York, New York 10017. Reference must be made to title, author, journal, and scheduled date of issue.
