**Submissions:** Submit manuscripts (2 copies) to Editor, *Review of Scientific Instruments*, Argonne National Laboratory, 9700 South Cass Ave./8293, Argonne, IL 60439-4871. Submission implies that the manuscript has not been published previously and is not currently submitted for publication elsewhere. **Publication Charge:** Although the journal carries no regular page charge, for any regular published article that exceeds 10 journal pages, a mandatory \$150 page charge will be added for each page in excess of 10 pages.

**Color Printing:** Authors or their institutions must bear the cost of any color they wish to use in their papers. A fixed rate of \$650 for the first color figure and \$325 for each additional color figure applies. For multipart figures, a single charge will apply only if all parts are submitted as a single piece of artwork.
