**Publication Charge:** Although the journal carries no regular page charge, for any regular published article that exceeds 10 journal pages, a mandatory \$150 page charge will be added for each page in excess of 10 pages.

A fixed rate of \$650 for the first color figure and \$325 for each additional color figure applies.
